2. Requirements regarding the bibliography

Pay a big attention because here occur the most mistakes than anywhere else in the article body. The introduction of citations and compilation of a bibliographic list are a proof of scientific integrity of the author. Failure to do so leads to plagiarism.

- All bibliographic references made in the text must be found in the bibliographic list.
- The ways of drafting the bibliography vary a lot from one journal to another. (Attention to "Recommendations for authors" that journal publishes)

A practical way of compiling a bibliographic list is to write down all the details linked bibliographic sources (authors, year of appearance, title, publishing house, town, name of the journal, pages, links in online, accessed data etc.)

The Review of Financial Studies uses the system author data named also Harvard system.

Citation in the text and compliance of references list in the Harvard system

Citation in text

Citation in the article may be done by direct or indirect **paraphrasing** (resuming the concepts or the ideas from one or more authors paper through personal words) or using **citations extracted** from a scientific work. The author (s) with the publication year are quoted in the text. Some magazines require to be indicated also the page (s). When there are two or three authors the name is quoted, and when there are four or more there will be written the name of first author, followed by "et.al.".

Paraphrase

• *Quote with only one author:*

(Popescu 2004) or Popescu (2004) (Popescu, 2011, p.90).

And if the same author is quoted with two or three papers, but with different years: (Săvoiu 2003, 2005, 2008)

- Quote with 2 or 3 authors:
- (Popescu and Tăchiciu, 2005) or Popescu and Tăchiciu (2005)
- (Săvoiu, Tăchiciu and Dinu 2012) or: Săvoiu, Tăchiciu and Dinu (2012)
- Quote with 4 or more authors:

```
...... (Popescu et al., 2001) or Popescu et al. (2001)
```

If the same author or group of authors published more papers in the same year, the difference will be made by letters added after the publishing year:

...... Popescu and Tăchiciu (1998a); Popescu and Tăchiciu (1998b).

Quotation with extracts from source text

When there are used the exact words to quote from the source, the proposition, phrase or the statement must be placed between the quotation marks, being introduced as follows:

- The author asserts that "...."
- The author believes that"....."

If there are quotations longer than 40-50 words, then the quotation can be made as a separate paragraph, usually written with a smaller size of the letter and centered or highlighted separately, in a special way, as below:

The article is devoted to the binomial "public budget – global output" from the perspective of BARS curve. The first section characterizes the main conceptual premises of this approach. The second one includes an empirical analysis, using the statistics dates (1990-2013) for Romania, as an emergent European economy: there are involved three cointegration regressions (the smaller squares method, the canonical cointegrated regression and the dynamic method of the smaller squares) and three algorithms based on instrumental variables (the method of smaller squares in two stages, the generalized method of moments and the method of maximum verisimilitude with limited information). There are also presented some conclusions (Dobrescu, 2015, p.495).

In the references list

The references are written without a serial number, in alphabetical order, after the name of first author. If there are more references of the same first author, than the classification is made by the first letter of the second author, etc.

If there are the same authors for different references, their references will be classified after the publication year, starting with the oldest year.

If there are same authors with the same publication years for different references, the references are classified adding "a,b,c, ..." after the publication year and the classification will be made in this order.in this system, the name of the last author is preceded by "and".
